Donations were made to Victory Pride Parade, International Brotherhood of Electrical Workers, Together Against Poverty Society, and the Cumberland Memorial. Reports were presented on behalf of the Canadian Labour Congress and other organizations. Also, the musicians' union was invited to perform at the Canada 150 celebrations for free.

Island Health has a new contractor for their custodial services and wages have gone down again. A worker with 14 years of service had their wage reduced by \$2 per hour. BCTF reported the Richmond School may be reopened, due to the need for more space resulting from the Supreme Court ruling regarding (lower) teacher/student ratios. Also, it was reported by another CUPE Local, that the level of cleanliness has been downgraded by the School Board.
