- Recreation and Personal Interest Courses/Workshops: Activity that generally contributes to an employee's physical and mental well-being. Activities are for enjoyment, amusement, or pleasure.
- **Convention/Conference:** A meeting of delegates to discuss or engage in a common interest or issue. It generally includes a keynote speaker(s), workshops, and vendor displays.
- Official Receipt: A receipt that includes the business name, address, phone/email, activity; shows received from the CUPE member's name, and shows as paid.
