There will be level 1 training for new members soon and Shane and the management rep were invited to the last SLC meeting.

#### 12. New Business

# 12.1 CUPE SD Fund – update/discussion

An SD Fund report prepared by the Education Coordinator was distributed. The Local wants the College to come up with more real time information going forward. It is anticipated that the fund will run out of money and members may not know that the Fund has run out of money, until they receive an email saying they will not receive reimbursement. The Local has put a system in place to monitor the Fund as closely as possible.

A suggestion was made that the fund be split into quarters and that members who have not claimed before get precedence. There was another suggestion that we could keep track of approval amounts and immediately subtract them. Keith stated that the Labour Management reps will be going back to LMCC and will put pressure on the employer. Erynne stated that the major issues with the SD Fund is overuse and the fact the College has been targeting it for training of its employees.

Dawn explained that the SD fund is a bit of a moving target and it is difficult to determine exact amounts. No approval will be fully realized, until it is actually paid. Regretfully, whatever the membership puts into place will disadvantage someone. It is important to note that in addition to the \$30,000 deficit carryover from the fiscal year ending March 31, 2018, a \$40,000 surplus carryover from the preceding year ending March 31, 2017, was also used. Thus, an extra \$70,000 was reimbursed, during the 2017-2018 year, on top of the contributions for that year.

- The Secretary-Treasurer expects the Fund will be exhausted this year
- The Chief Shop Steward thanked Shelley and Petty for their efforts.
- A member suggested a poll of members or taking the issue to CUPE BC/National or filing a grievance.
- 12.2 **Retirement Planning workshop** unilaterally increased from 2 days to 2.5 days by CUPE National.

#### 13. Nominations, Elections, or Installations (if required)

13.1 **MSC**: THAT CUPE LOCAL 2081 send the President and one Delegate to the 58<sup>th</sup> Constitutional Convention of the BC Federation of Labour, Vancouver, BC, November 26-30, 2018, at an individual cost not to exceed three thousand three hundred dollars (\$3,300.00) per Delegate and for a total cost not to exceed six thousand six hundred dollars (\$6,600.00).

Erynne Grant was nominated, accepted the nomination, and acclaimed, to be a Delegate to the BC Fed convention.

13.2 MSC: THAT CUPE LOCAL 2081 pay the Colleges and Institutes Support Staff Bargaining Association (CISSBA) four thousand four hundred fifty dollars and three cents (\$4,450.03) at thirty two decimal one percent (32.1%)\* for our portion of the costs for the arbitration of the Provincial Grievance against the Post-Secondary Employers Association (PSEA) regarding prescription drug coverage from the last round of bargaining. (\*based on membership numbers)

# 13.3 **MSC** (unanimous): THAT CUPE LOCAL 2081 convey a Lifetime Membership on IDA COLANTONIO per Section 3B of the By-Laws.

The Membership may convey a "Lifetime Membership" on an individual who has contributed to the betterment of the Local. A "Lifetime Member" shall have voice, but no vote, at all Membership Meetings of the Local.
