Petty reported that there were 655 total members in September: 262pt and 393 Ft

Petty also reported that the Local has not renewed any term deposits to free up cash resources during the bargaining period and there is about \$600, 000 in the bank. In terms of the allocated capital budget for office improvements, \$2932.50 of the \$10, 000 budget has been spent on laptops and some furniture.
